The Board discussed the material bid concerning the cost for the base asphalt and should the township pick up at Hawbaker location since it was further than IA Construction. Since it would cost more in fuel to pick up at Hawbaker location, even though the cost of the base asphalt is a little lower in price, all material was awarded to IA Construction.

Steve asked questions concerning how the bids were being accepted for the grader since a local contractor had submitted a bid for more than \$3,500.00. The Township Secretary, Susan Gibiser explained that the Board motioned and approved to advertise the equipment on the Municipal Bid website since the township was getting better bids and selling all of the equipment on this site. Susan provided the information to the Board pertaining to the bids; she also explained that she received an email from the local contractor a week after the bidding was closed. The Township advertised locally twice in 2019, only received one bid for the amount of \$1,500.00 and it was not from the same local contractor that recently sent a bid by email.

 Motion was made to advertise to accept sealed bids for a 35 KW generator for the lift station located on Fuller Road.

Dave Geitner asked questions concerning the Bradford Manor Therapy plans; asked if the township would be able to bill the City of Bradford for having their fire hydrants in the township's right-of-way.
