Ordinances and Resolutions

 Motion was made by Mark Cline to adopt <u>Resolution #2020-19</u> which states that Bradford Township is repealing the annual Assessment for Electricity rates for the Township's Street Lighting and authorizing payment for the Electricity with the use of the Township's Liquid Fuel Fund.

Supervisor Mascho stated he didn't agree with repealing the electric assessments for the residents that have street lighting on or by their property and using the Township's Liquid Fuel fund to pay for the lighting since these funds are used for Township roads.

Motion made by Mark Cline, seconded by Jim Erwin Vote: Steve M.: NO; Mark C.: Yes; Jim E.: Yes

- Motion was made by Mark Cline to adopt the 2021 proposed budget for all funds as advertised and presented as follows:
 - 1) <u>General Fund</u> -- which includes a millage increase of one (1) mill for all Real Estate Property within the Township.
 - 2) Garbage Fund with no increase to residents
 - 3) Sewer Fund -- with no increase to residents
 - 4) <u>State Liquid Fuel Fund</u> -- which includes the cost for Electricity for Street Lighting
 - 5) Lighting Fund which is not included in the 2021 budget

Supervisor Mascho stated he didn't agree with the 2021 budget and the Township should not be raising the millage at this time since some of the residents are having a difficult time due to loss of jobs and the pandemic; Jim Erwin stated the Township did not raise the sewer or garbage rates for the residents after the rate increased to the Township from both Casella's for garbage and the City Sanitary Authority for sewer.

Motion made by Mark Cline, seconded by Jim Erwin Vote: Steve M.: NO; Mark C.: Yes; Jim E.: Yes

 Motion was made by Mark Cline to adopt <u>Resolution #2020-20</u> which states Bradford Township enacts and levied on all real estate property within the township of Bradford to taxation for the fiscal year of 2021 at five (5) mills.

Motion made by Mark Cline, seconded by Jim Erwin Vote: <u>Steve M.: NO;</u> Mark C.: Yes; Jim E.: Yes

 Motion was made by Steve Mascho to adopt <u>Resolution #2020-21</u> which states Bradford Township enact the Local Taxes of Act 511 for the year of 2021 with no increases for EIT tax, Local Service tax, Per Capita tax.

 Motion was made by Mark Cline to accept the proposal from Land Services Group, Cunningham Surveyors to conduct a Topographical Survey for the East Warren Road Bridge Replacement Project at a cost of no more than \$6,800.00 Supervisor Mascho stated since the Browntown Bridge was replaced, the Township doesn't need to replace the East Warren Road Bridge and the Township should wait until grant funding is available.

 Motion was made by Mark Cline to accept the proposal from GTA,
 Geo-Technology Assoc. to conduct a drilling and foundation report for the East Warren Road Bridge Replacement Project at a cost of \$7,500.00 - \$10,000.00

 Motion was made Mark Cline to accept the Memorandum of Agreement that references the 2021 Wage Rates for all Teamsters Union members as written for each Department and Clerical.

Supervisor Mascho stated there should be no changes in the union contract for wages since the contacts states increases for next year.
