REGULATIONS FOR DEMOLITION OF PROPERTIES LOCATED IN BRADFORD TOWNSHIP

- ✓ Must follow the regulations set forth in the PA Solid Waste Management Act (ACT 97) and Section 129.14 of the Air Quality regulations. (A copy is on file at the Township office or can be found on line at www.state.pa.us; state agency environmental protection.)
- ✓ Section 6018.610(3) of Act 97 states that, "It shall be unlawful for any person or municipality to burn solid waste without a permit from the Department of Environmental Protection."
- ✓ Section 610. Unlawful conduct.

It shall be unlawful for any person or municipality to:

- (1) Dump or deposit, or permit the dumping or depositing, of any solid waste onto the surface of the ground or underground....
- (2) Burn solid wastes without a permit from the department. (DEP)
- ✓ It is the responsibility of the parties completing the demolition to remove <u>ALL</u> debris from the demolition site and said debris must be transported by a registered waste hauler to a State approved disposal site.
